Payments made with a credit card will be charged an additional 5% processing fee.*

CLOSING BOOTH TIME: All of our shows are scheduled to close at a certain time. Should you decide to close your booth before the scheduled time, you will be charged a \$50 fine which you must pay before you are able to open your booth the next show day.

RULES & REGULATIONS

1. This contract is personal to exhibitor, and the exhibitor may not assign this contract, nor any right included with this contract, nor shall he give any security interest in this contract, nor shall this contract be assigned to anyone else. Any attempted assignment of rights, or security interest of this contract by the named exhibitor shall at C & S Events LLC/AKS Gem Shows, (hereafter known as C&S) discretion, constitute a breach of Contract and shall void the Contract and all moneys shall be forfeited.
2. It is expressly intended by the parties that this is a nonexclusive, revocable contract, and that this contract shall **not** be deemed, construed, or held to be a lease, sublease or rental agreement. The relationship of C&S/AKS and the exhibitor is intended to be that of a licensor/licensee and not that of landlord/tenant, principal/agent, or partner or otherwise.
3. It is understood and agreed that exhibitor has no interest whatsoever in the real property upon which exhibitor' exhibit/concession is located and no right to exclusive possession of any portion of the real property in which the exhibition/show is held. Exhibitor' right of access to the premises shall be limited to the hours of operation of C&S.
4. Exhibit spaces will be available at times specified. **All exhibits must be kept open during the posted show hours. Should you be found closing your booth before the closing time you will be charged a fine of no less than \$50 and you will not be able to open until you pay the fine.** No visible packing may be done before the specified closing time and booths must be occupied during the posted how hours. Leaving early constitutes a breach of contract and possible expulsion with full loss of show fees paid.
5. Anyone not occupying their booths by the specified opening time on opening day will forfeit their right to occupy said booth, and no refund will be made.
6. Space assignments are made by show management. Signing this contract/application constitutes acceptance and no refunds will be made.
7. Buyers may not be solicited in the halls or aisles, or in any **other** exhibitor space. Exhibitor may not have models, signs, or other solicitation devices outside his space. Badges must be worn by all exhibitors and sales personnel while on show premises. Exhibitor, or his employees, may not distribute printed matter without the express written consent of C&S/AKS management.
8. The exhibitor may not display or sell goods that are counterfeits, copies, or reproductions, etc. unless clearly marked as such.
9. Exhibitor does not have the right to interfere, disrupt, or cause any harm to C&S/AKS, the individual show or to another exhibitor. Such disturbances or interference is cause for immediate loss of show space, removal from the property, and total loss of show fees and/or deposits.
10. In the event of war, fire, strike, government regulation, public catastrophe, act of God, or public enemy, disorder or causes beyond the control of the management, and the show or any part thereof is prevented from being held, is canceled by management, or the exhibit space becomes unavailable, management shall determine and refund to the applicant his proportionate share of his balance or applicable payment which remains after deducting expenses incurred by the management and reasonable compensation to the management, but in no case shall the amount of refund to the applicant exceed the amount of payments paid. In no event shall management be liable for loss of profits, business, or other damages incurred by the Applicant.
11. C&S shall have the right to substitute other available space or to change the date when the show shall be held, giving the exhibitor notice thereof by mail *addressed to the address* given by the exhibitor, at as early a date as may be practicable and all of the terms and conditions hereof shall apply with full force and effect as if said new space time and/or place had been originally specified.
12. Neither management nor any of its agents, employees, officers, or any other representatives shall be held accountable or liable for and the same hereby released from all accountability or liability for any damage, loss, harm, or injury to the person or any property of the applicant, or any of its officers, agents, employees, or other representatives, resulting from theft, fire, water, accident or any other cause, and management will not obtain insurance against any such damage, loss, harm, or injury. The contract herein granted is revocable by management at any time in the event exhibitor shall violate this agreement.
13. Applicant hereby agrees to indemnify, defend and protect management against and hold and save the management harmless from any and all claims, suits, demands, liability, loss, costs, damages, attorney fees and expenses of whatever kind of nature which might result from or arise out of any action or failure to act to the applicant or any of its officers, agents, employees, or other representatives.
14. Exhibitors must not throw refuse, or any other material on the floor, grounds, or common areas of the exhibition. Exhibit must be cleaned and put in proper order before the show opens each day. The management at the expense of the exhibitor may clean booths that are not cleaned before the close of the show.
15. All exhibitors are subject to, and must pay any city or state sales licenses. The city, state (or in some states C&S/AKS) will come and collect sales taxes/fees, or provide you with the necessary forms for you to complete and return with any fees due.
16. Trucks, trailers, motor homes, or any other device used to transport merchandise will be stored in auxiliary parking area provided by management. Personal vehicles of dealers and their employees must park in their designated area.
17. Exhibitor will observe all regulations of C & S Events/AKS Gem Shows, as well as those of the city, building, police, and fire department.
18. Exhibitor agrees to pay a nonrefundable show fee. This will grant exhibitor the right to display their goods during exhibition dates.
19. Exhibitor gives management the permission to provide any information to anyone at the show.
20. The space contracted for is to be used solely by the exhibitor whose name appears on the contract, and the exhibitor shall not sublet or assign any portion of same without the written consent of C&S. No exhibitor shall exhibit or permit to be exhibited in the space contracted to him, any merchandise other than his own display or any advertising signs except his own. All signs or advertising must be approved by C & S, the fire department, the facility, and any official agency of the city or state. In the event of any violation of this rule occurs the exhibitor will forfeit his space and no refund will be made.

These rules, regulations and conditions have been drawn for the purpose and intention of providing everyone with a balanced, well regulated, attractive and successful show. In an effort to provide the greatest good to the greatest number, the management shall have full power to so interpret the rules and regulations or to make such rulings as may appear to be for the best interest of the entire show. Any and all amendments for the foregoing rules, regulations and conditions shall bind the exhibitor to AKS rulings.
